Legal nature

Public-law entity, with a legal personality and full capacity to act.

Independent from other public administrations and **neutral**.

Ascribed to the Parliament of the Valencian Community,

who appoints the General Director.







General Director

The highest authority.

Elected by the **parliament** by a **majority of three-fifths** with **seven years** term of office. -Parliament is elected for four years-

He/She's unmovable and can not be reelected.







General Director

The highest authority.

Elected by the **parliament** by a **majority of three-fifths** with **seven years** term of office. -Parliament is elected for four years-

He/She's unmovable and can not be reelected. The Director is accountable and reports directly to the Valencian Parliament

- Preventive actions against fraud and corruption. Elaboration of **plans** and **risk maps.**
- Personnel training in integrity and public ethics.
- Documentation, studies and preliminary risk analyses.

The protection of the whistleblower

The whistleblower receives immediate legal advice.

He/She may ask for **protection**.

This right extends to the spouse, siblings and descendants.

If retaliation, the Agency will take corrective or restorative action.

In the case of the acts or omissions established by law, the Agency has **sanctioning power**.

The sanctioning power

Applied by the Director.

For cases of **deceit**, **fraud or gross negligence**. Acts or omissions established by **Law**.

Sanctions from €200 to €400,000

and reprimand, statement of breach of duty or publication in the Official Gazette of the Valencian Community depending on the sanction resulting from an offence classified as minor, serious or very serious.









Civil servants from any public administration.

Staff with investigative functions have the status of public authority



Civil servants from any public administration.

Staff with investigative functions have the status of public authority They are enable to:

- Visit any office or premises in order to request information, make checks and examine all kind of documents.
- Conduct personal interviews.
- Access the current account information held by banks, if this is permitted by current legislation.
- Make copies or certified photocopies of documents under investigation.



If during the development of the procedure the facts investigated reveal a **criminal offence**

the Agency will collaborate with

the Public Prosecutor's office

or the relevant **judicial authorites**



with the following **actions**:

- a) Stoping its studies or investigation.
- b) Providing them with all the documents or information in its possession.
- c) Puting itself at their disposal to provide whatever support and collaboration may be necessary.





Procedure



Collaboration with the Court of Accounts

referring the action of its jurisdiction in the case of possible **accounting responsabilities.**





ALETHEIA PROJECT

Project of technological research to improve **public procurement**.

Traceability registration system using the blockchain technology.

It records a public expense related to procedures and **analizes** the data obtained **to detect** certain suspicious patterns.
